Speed limit.

**8.** Whoever commits an offence against any of the foregoing regulations shall on summary conviction be liable to a fine not exceeding eighty dollars.

**9.** (1) Save as hereinafter specified, the speed limit for motor vehicles throughout the Districts of Governor's Harbour, Harbour Island and Rock Sound shall be forty-five miles per hour for motor vehicles other than omnibuses having a seating capacity for more than twenty passengers or motor trucks for which the speed limit shall be thirty miles per hour.

(2) The speed limit for all motor vehicles shall be fifteen miles per hour within the limits of settlements in the said Districts or along such lengths or parts of any road where it is so indicated by traffic signs.

**10.** The provisions of regulation 9 of these Regulations shall not apply to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes if the observance of these provisions would be likely to hinder the use of such vehicle for the purpose to which it is being used on that occasion.

## **ROAD TRAFFIC AND SPEED LIMIT (GRAND BAHAMA) REGULATIONS**

**1.** These Regulations may be cited as the Road Traffic and Speed Limit (Grand Bahama) Regulations.

Speed limit.

**2.** (1) Save as hereinafter specified the speed limit for motor vehicles throughout the Island of Grand Bahama shall be forty-five miles per hour for motor vehicles other than omnibuses having a seating capacity for more than twenty passengers or motor trucks for which the speed limit shall be thirty miles per hour.

(2) The speed limit for all motor vehicles shall be twenty miles per hour within the limits of settlements in the aforesaid Island or along such lengths or parts of any road where it is so indicated by traffic signs.

**3.** Notwithstanding the provisions of regulation 2 hereof, the speed limit of thirty miles per hour shall be observed by all motor vehicles wherever it is so indicated by traffic signs.

**4.** The provisions of regulation 2 of these Regulations shall not apply to any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes if the observance of these provisions would be likely to hinder the use of such vehicle for the purpose to which it is being used on that occasion.

**5.** The provisions of paragraphs (1), (2), (3) and (4) of regulation 13 of the Road Traffic Regulations and of regulations 2 and 3 of these Regulations shall not, between the hours of 10:00 a.m. and 5:00 p.m. on any day during the month of December, apply to any motor vehicle on the occasion of its taking part in motor races then being held on certain approved roads in Freeport; and for the purpose of this regulation, "approved" means approved by the Minister.

**6.** With effect from the coming into force of the Road Traffic and Speed Limit (Freeport) Regulations, these Regulations shall cease to apply in relation to the Port Area.

## **ROAD TRAFFIC AND SPEED LIMIT (NICOLL'S TOWN, ANDROS) REGULATIONS**

(SECTION 43(2))

*[Commencement 16th February, 1963]*

**1.** These Regulations may be cited as the Road Traffic and Speed Limit (Nicoll's Town, Andros) Regulations.

Citation.

**2.** The provisions of these Regulations shall apply to the Nicoll's Town District of the Island of Andros and shall be in addition to any of the provisions of the regulations made under the Road Traffic Act which are applicable to the said Island.
