| <p>1. This Order may be cited as the Motor Car (International Circulation) Order.</p> <p>2. This Order, unless the context otherwise requires —</p> <p>“Act” mean the Road Traffic Act;</p> <p>“motor car” has the same meaning as is ascribed to “motor vehicle” in the Act;</p> <p>“convention” means an International convention relative to motor cars and traffic.</p> <p>3. Any person resident in The Bahamas who desires to use a motor car registered and licensed in The Bahamas in any other country or state which shall have adhered to any convention to which The Bahamas has adhered, shall apply to the Controller of Road Traffic in Form I of the Schedule to this Order for an International Certificate and Identification Plates in respect of the motor car for which it is required. Such an International Certificate and Identification Plates shall be supplied by the Controller of Road Traffic.</p> <p>4. (1) The applicant must satisfy the Controller of Road Traffic before the issue of an International Certificate and Identification Plates, that the motor car complies with the requirements of the convention and for such purpose the Controller of Road Traffic may require the motor car for which the certificate and plates are required to be examined and a report made thereon.</p> <p>(2) The fee payable for the International Certificate shall be twenty five dollars.</p> <p>5. Every applicant to receive a certificate, etc., under paragraph 4 of this Order, must carry, in a visible position in the rear of such motor car, the distinguishing letters “BS” written on the Identification Plate. These letters must be painted on an oval plate 30 cms. wide by 18 cms. high in black on a white ground. The letters must be at least 10 cms tall and their strokes of a width at least 15 mms. 6. The Controller of Road Traffic shall keep a register of all International Certificates issued by him and of all motor cars being used in The Bahamas under the authority of International Certificates issued in other countries.

7. (1) The owner of any motor car in respect of which an International Certificate and Identification Plates have been issued elsewhere than in The Bahamas, under any convention to which The Bahamas shall have adhered, may whilst such certificate remains valid, be exempted from any requirement to register or hold a licence in respect of such motor car in The Bahamas for a period not exceeding three months.

(2) In such case it shall be necessary only to present such certificate to the Controller of Road Traffic for proper recording and endorsement; thereupon the same shall be effective in The Bahamas in accordance with subparagraph (1) of this paragraph.

8. If any person possessing an International Certificate sells or otherwise disposes of his motor car in The Bahamas, such disposal or sale shall immediately be notified to the Controller of Road Traffic and any failure to do so shall render such person and the purchaser of such motor car liable to prosecution for a breach of section 31 (1) of the Act and the motor car to seizure by the police. If such person remains in The Bahamas with his motor car beyond the period of three months, he shall be treated in all respects as a resident.

9. Where a person in The Bahamas desires to drive a motor car in any other country which shall have adhered to any International Convention as aforesaid he shall apply to the Controller of Road Traffic in Form II of the Schedule to this Order for an International Driving Permit. The applicant must comply with the requirements of the said convention and shall, in addition to such other particulars as may be required by the Controller of Road Traffic, satisfy him that he holds a valid driver's licence issued in The Bahamas and that he is ordinarily resident in The Bahamas. The Controller of Road Traffic shall have

power to issue International Driving Permits in accordance with any convention as aforesaid on payment of the sum of twenty five dollars to the Treasurer of The Bahamas. Such permits shall, unless suspended by a court, remain in effect for twelve months from the date of issue.

10. The holder of an International Driving Permit issued elsewhere than in The Bahamas and in accordance with the provisions of any convention with respect to the International Circulation of Motor Cars to which The Bahamas shall have adhered, shall whilst such permit remains valid, be exempted from any requirement to hold a drivers licence to drive a motor car within The Bahamas. Such permit shall only be valid for the duration endorsed thereon.

11. The Controller of Road Traffic shall keep a special register in which he shall record the particulars of all drivers' permits endorsed or issued by him. Endorsement shall be effected by impressing his office stamp upon the permit and signing and dating same.

12. No motor car in respect of which an International Certificate, etc., has been issued elsewhere than in The Bahamas shall be used in The Bahamas for hire or trade purposes.

ROAD TRAFFIC (SPEED LIMIT) (ST. GEORGE'S CAY AND RUSSELL ISLAND) REGULATIONS, 2000

(SECTION 92)

[Commencement 3rd August, 2000]

1. These Regulations may be cited as the Road Traffic (Speed Limit) (St. George's Cay and Russell Island) Regulations, 2000.
