**ROAD TRAFFIC (SPEED LIMIT) (ST. GEORGE'S CAY AND RUSSELL ISLAND) REGULATIONS, 2000**

66/2000

(SECTION 92)

*[Commencement 3rd August, 2000]*

**1.** These Regulations may be cited as the Road Traffic (Speed Limit) (St. George's Cay and Russell Island) Regulations, 2000. Citation.

**2.** The provisions of these Regulations shall apply to St. George's Cay and Russell Island and shall be in addition to any of the provisions of the regulations made under the Road Traffic Act, which are applicable to the said islands. Application.

Major and minor streets.

**3.** (1) The following streets shall be deemed to be main streets with rights of way thereon —

- (a) South Road, the main road which runs through the southern portion of St. George's Cay;
- (b) Samuel Guy Pinder Road, the main road which runs through the centre of St. George's Cay.

(2) All other streets on St. George's Cay shall be deemed minor streets.

(3) All minor streets on St. George's Cay running north to south shall be numbered one to thirty-two starting from the east and the number of every street shall be the name of that street.

Parking.

**4.** (1) Except as otherwise herein specified, a vehicle may be parked in any public place.

(2) Parking shall be permitted only on the northern side of all streets running east to west and only on the eastern side of all streets running north to south, except that no parking shall be permitted on streets which are less than twelve feet wide or any area designated and marked as a no parking area.

Directions in which vehicles shall not be driven.

**5.** Vehicles shall not be driven northwards on the following streets —

- (a) Thirtieth Street, between South Road and Samuel Guy Pinder Road;
- (b) Ninth Street, between the point where Eight Street continues westwardly on to Ninth Street and Samuel Guy Pinder Road;
- (c) Sixth Street, between South Road and Samuel Guy Pinder Road.

Speed limit.

**6.** (1) Vehicles shall not be driven on any of the following streets at a speed greater than twenty miles per hour —

- (a) all minor streets on St. George's Cay;
- (b) South Road east of Fourteenth Street;
- (c) Samuel Guy Pinder Road east of Tenth Street.

(2) The speed limit on the following streets shall be twenty-five miles per hour —

- (a) Samuel Guy Pinder Road west of Tenth Street;
- (b) South Road west of Fourteenth Street;

(c) all streets on Russell Island between the eastern end of Ocean Heights Subdivision and the western end of Ocean Estates Subdivision.

(3) The speed limit on all streets on Russell Island which are east of Ocean Heights Subdivision and west of Ocean Estates Subdivision shall be thirty miles per hour.

(4) The speed limit on the bridge connecting St. George's Cay to Russell Island and on the bridge south of the dry dock on South Road shall be ten miles per hour.

(5) The speed limit in any designated school zone shall be fifteen miles per hour between the hours of 7:30 a.m. and 3:30 p.m. on school days.

7. The provisions of regulation 6 of these Regulations shall not apply to a vehicle on an occasion when it is being used for the fire brigade, an ambulance or police purposes if the observance of these provisions would be likely to hinder the use of that vehicle for the purpose for which it is being used on that occasion.

Use of vehicles in emergency.

8. Whoever commits an offence against any of the foregoing regulations shall be liable on summary conviction to the penalties prescribed for breach of the speed limit set out in section 43 of the Road Traffic Act.

## **ROAD TRAFFIC (MOTOR CYCLES) (PROTECTIVE HELMETS) REGULATIONS**

S.I. 44/1975

(SECTION 98)

*[Commencement 1st July, 1975]*

1. The Regulations may be cited as the Road Traffic (Motor Cycles) (Protective Helmets) Regulations.

Citation.

2. Every person driving and riding on a motor cycle shall wear at all times a protective helmet of the shape, construction or other qualities set out in regulation 3 of these Regulations.

3. Protective helmets referred to in regulation 2 of these Regulations shall conform to the standards set by the International Organization for Standardization.
